Central Washington Sports Hall of Fame Nomination and Selection Guidelines

The Central Washington Sports Hall of Fame is a project of the Tri-Cities Sports Council and made possible by our corporate sponsor, Fluor Hanford. The Tri-Cities Sports Council is a special program of the Tri-Cities Visitor & Convention Bureau.

1. Nomination and appropriate documentation may be submitted for one of the following categories: Athlete, Coach, Official/Referee, Sports writer or Broadcaster, Super Fan and Special Contributor.
2. In addition to sports achievement, the committee will consider the impact the nominee has had on his/her sport or sports in general, the contribution the individual has made to his/her community through sports or some other activity, and the lasting impression the individual leaves to future generations.
3. To be eligible for nomination to the Central Washington Sports Hall of Fame, the candidate must have been a resident of Central Washington (Klickitat, Yakima, Kittitas, Chelan, Okanogan, Douglas, Grant, Benton, Adams, Franklin, Walla Walla, Columbia, Garfield and Asotin counties.)
4. No athlete is eligible for consideration until five years after his or her last competition. Others are eligible at the discretion of the committee. Under special circumstances, the Hall of Fame selection committee has the ability to waive the five-year requirement.
5. The Central Washington Sports Hall of Fame shall limit its selection to no more than six.
6. Nominations should be submitted to the Tri-Cities Visitor & Convention Bureau, Central Washington Sports Hall of Fame Selection Committee, PO Box 2241, Tri-Cities, WA, 99302-2241. Nominations should be submitted with as much detail and supporting information as possible. Of particular importance are the nominee's full name, current address, and a list of achievements for which he/she is being nominated.
7. A person selected for the induction into the Hall of Fame will be required to provide an appropriate photograph portraying the individual at the peak of his/her career as well as a memento of the individual, both to be displayed in the Central Washington Sports Hall of Fame.
